What should be the Town of Newmarket's priorities for the next 5-10 years?

STOP SPENDING MONEY ON USELESS SHIT LIKE THE ARCH WAY

Single dwelling homes take up too much space - the town needs to focus on both a greater ratio of affordable house in multi-tier lower rise condominiums and rental units. Only with a greater property tax base can we start to pay down outstanding debt as our capacity to produce more jobs, other than in the seasonal smaller footprint food services sector is non existent. Also a great way to fill all those great big shiny blue buses...supposedly.

Enough focus has been paid to the downtown area - time to enhance other areas of town such as Davis, Yonge, Bayview and Leslie.

My biggest concern is trustee accountability. It has come to my attention that some of the York region district school board trustees have been travelling to Finland for so-called research but have not demonstrated any measurable evidence to justify such expenses.

Organization Ready 2020 should be the top priority because it is critical to our long term sustainability. Revitalizing Davis Drive & Yonge will help create jobs. Street safety is an important priority.

With the expansion of Davis drive to 6 lanes, we are at risk of creating a corridor in the center of town which extremely unfriendly to pedestrians, similar to Ajax. We need to be proactive about preventing this.
